### Application Administration updates description

#### [Description of updates from version V13.0 onwards](#)

##### V9.1.1, 14 May 2022

- In the **Home library** editor in the **Data for COLIB (2)** tab, the attribute name "AAI acronym" was changed to "AAI organisation domain".

##### V8.0, 27–28 November 2021

- For COLIB records (**COLIB** class objects), for school libraries in Slovenia, the folders **MIZŠ institutions** and **MIZŠ programmes** were added to the links for the purposes of managing the textbook fund. The **MIZŠ institutions** folder contains institutions, a part of which is the selected library. The **MIZŠ programmes** folder contains programmes performed by the listed institutions. The data is acquired from the Slovenian Ministry for Education, Science and Sport. In the **COLIB record** editor, the **MIZŠ institutions** and **MIZŠ programmes** tabs are visible in the **Details** tab.
- In the **Home library** editor, the attribute "AAI acronym" was added in the **Data for COLIB (2)** tab. The data is appointed to the library by the Slovenian Research Agency (ARNES) and is one of the conditions that the member can login to COBISS+ via the ArnesAAI Federation (for more information, see <https://plus.si.cobiss.net/opac7/help#na%C4%8Dini-prijave>).

##### V6.28-00, 27–28 February 2021

- In the home library, when entering data on the library or its departments, which you enter for the purposes of the COBISS+ software and the mCOBISS app (in the **Home library** editor in the **Data for COLIB (2)/Dpt./Op.times** tab and the **Data for COLIB(2)/Departments (COBISS+m mCOBISS)** tab), a software control was activated when entering the working times in days and hours.

##### V6.27-00(09), 21 November 2020

- Bug fix in the display of library data saved in the COLIB database.

##### V6.26-00(01), 30 April 2020

- Bug fix:
  - when deleting a partner with the role *Supplier (ER)*.


#### V6.24-00, 7–8 December 2019

- In the window for entering contact details about the lending departments for the needs of COBISS+ and mCOBISS (in the **Home library** editor under the **Data for COLIB (2)/Departments (COBISS+, mCOBISS)** tab), you can now also enter the information about opening times of departments for their users (working times in days and hours), and a note.

#### V6.23-00, 21 August 2019

- Attributes for entering messages in English displayed when reserving material through COBISS+ and in online login are added to the contact details and information for COBISS+ if English is selected as the interface language in COBISS+. In new attributes for messages, English texts are already entered (default values). If you are not satisfied with the contents, you can change them.
- Bugfix in saving contact data and information for COBISS+ after changing the time parameters valid for priority reservations.

#### V6.22-00, 8–9 June 2019

- In the window for entering contact details about the library and its lending departments for the needs of COBISS+ and mCOBISS (i.e. the **Departments (COBISS+, mCOBISS)** window that opens when you select a library or a department in the **Home library/Data for COLIB (2)/Departments (COBISS+, mCOBISS)** editor), the **Open COLIB** button is added; use this button to check whether you have entered correct GPS coordinates for the display of the library location or the department location on the map. When you click this button, the default browser will open and the page with library details from the COLIB database will be downloaded. In the part of the window where the map is displayed, click on  to check whether the location found is correct and whether you entered correct GPS coordinates among the details.
- The "E-mail address for reservations" attribute is removed from the contact details and information for COBISS+ and from the lending department data.
- The "Payment due (days)" attribute is removed from home library data.
- For the home library, the name of the attribute for restricting the interlibrary loan orders via COBISS+ ("ILL restriction (COBISS+)") and the name of the attribute for entering the web page address that is available to members via COBISS+ and where the library can publish the terms and conditions for ordering material and the price list of ILL services ("Ordering terms (COBISS+)") are changed.

- Among contact details and information for COBISS+, the name of the attribute for entering the web page address where the library can publish contact details and notifications related to My library service ("Contact details and info (COBISS+)") is changed.
- Correction in lending departments details; the information about the number of items currently ordered via interlibrary loan and the information about the number of items from the selected department that are currently on interlibrary loan are visible only in the libraries with departments for which it is enabled with a special parameter to determine one or more superior partners for an individual department.

#### V6.16-02, 31 March 2018

- For the "Home page" attribute in the **Home library/General** editor and **Partner/General** editor, and for the "Ordering terms (COBISS/OPAC)" attribute in the **Home library/Details** editor, you can now enter text that is 200 characters long.

#### V6.13-03, 28–29 October 2017

- The attribute "UJP identification number" is removed from the **Home library** editor, because the library submits this information through the form for inclusion into online payments.

#### V6.10-03, 25–26 March 2017

- Correction related to saving contact details of the library and its loan departments for the purposes of COBISS+ software and the mCOBISS application entered for the home library.

#### V6.10-02, 1 March 2017

- Correction related to saving the data entered in the home library and used for updating the COLIB database.

#### V6.10-01, 18–19 February 2017

- Correction related to saving the postcode of the home library head office and the lending departments for the purposes of the COBISS+ software and the mCOBISS application into the COLIB database.

**V6.9-00, 14–15 December 2016**

- The contact details of the library and its loan departments for the purposes of the mCOBISS application are now also taken into account in the COBISS+ software. For this reason, some terminological changes were required in the home library data related to updating the COLIB database.
